O R D E R

1. Mr. Nishant Ramakantrao Katneshwarkar, learned counsel for the State of Maharashtra, states, that he has obtained instructions from the State Government, which has now agreed to appoint an I.A.S. officer, in terms of the directions issued by the High Court, in the impugned order dated 2nd May, 2014.

2. A perusal of the impugned order reveals, that the concerned officer had to be appointed within 45 days from the date of passing thereof. In view of the fact, that the operation of the impugned order was stayed by this Court on 14th August, 2014, the State Government was obviously not obliged to implement the above directions. Since the matter has now been resolved, by an undertaking given by the State Government (to appoint an I.A.S. officer in tune with Section 13(2) of Shree Sai Baba Sansthan Trust (Shirdi) Act, 2004), we direct the State Government to post

the concerned officer in consonance with the impugned judgment, on or before 15th March, 2017.

3. The special leave petition is disposed of in the above terms.
